Trainees are expected to train/work from 40 to 60 hours per week depending on the season and need of the farm. Trainees will work 5 days a week and have 2 days per week off.

Trainees will work alongside and be closely supervised by farm owners and experienced farm employees.

**On-Site Training, Steward's primary activities :**

Trainee will participate in animal feeding, rotation, and care, cow milking, egg cleaning, irrigation, hay making, equipment maintenance, farmers market preparation, and (possibly) farmers market sales.
